



TEMPORARY PROTECTED STATUS (TPS)- HAITI SUPPORTING EVIDENCE CHECKLIST

IDENTITY AND NATIONALITY EVIDENCE-Demonstrate your identity and that you are a national of a country designated for TPS (or that you have no nationality and you last habitually resided in a country designated for TPS).

- A copy of your passport; or
- A copy of your birth certificate, accompanied by photo identification; or
- Any national identity document bearing your photograph and/or fingerprint issued by your country, or your country's Embassy or Consulate in the United States, such as a national ID card or naturalization certificate.

CONTINUOUS PHYSICAL PRESENCE EVIDENCE- Demonstrate that you were physically present in the U.S. since February 4, 2023.

- A copy of your passport with stamp showing data of entry; or
- I-94 Arrival/Departure Record if you arrived in the U.S. with a visa; or
- Copy of parole stamp and any other documents given to you at the border; or
- Copies of documents specified in the "Continuous Residence Evidence" section.

CONTINUOUS RESIDENCE EVIDENCE- Submit documents with your name and a date showing that you have been in the U.S. since November 6, 2022 such as any of the documents listed below:

- Employment records, pay stubs, taxes;
- Rent receipts, lease agreements, utility bills, receipts or letters from companies;
- School records or vaccination records for your children from the schools or doctors that you or your children have attended or visited in the U.S.;
- Hospital or medical records concerning treatment or hospitalization of you or your children; or
- Attestations by a church, union, or other organization officials who know you and where you have been residing.

CERTIFIED TRANSLATION-Any document that is not in English must be accompanied by a complete English translation. The translation must state: •

- The translator must be competent both in English and the foreign language used in the original document (In this case Haitian Creole); and

- The translation is true and correct to the best of his or her ability, knowledge, and belief.
- The translation must be signed and dated by the translator.

CRIMINAL CHARGES OR ARRESTS- If you were arrested or charge with a crime you will need to submit:

- Certified court disposition (if applicable).

IMMIGRATION HISTORY- If you have an immigration petition or application pending you will need to submit:

- A copy of the receipt notice (if applicable).
- Copy of Notice to Appear (if applicable).

TPS FILING FEES

- Over 14 and EAD (employment card): \$545
- Under 14: \$50
- 66 or older: \$135
- Cost is different if not applying for an EAD

FORM I-912 REQUEST FOR A FEE WAIVER- If you are unable to pay filing fees, submit a request for a fee waiver explaining why you are unable to pay filing fees.

- Copy of your most recent Income Tax returns (if available)
- Copy of W-2 and pay stubs
- Copy of lease agreement, utility bills, medical expenses and others to show monthly expenses
- Copy of COMPASS sheet if you or a family member receives public benefits in Pennsylvania (Medicaid, TANF, SNAP, CHIP other)
- If you do not have any income, financial support, or cannot provide evidence of income, submit affidavits from religious institutions, non-profits, community-based organizations, describing your particular situation that you believe qualifies you for a fee waiver
